

**PRIOR LAKE CHAMBER OF COMMERCE
ICE GOLF 2016 PARTICIPATION AND WAIVER FORM**

Refunds

Registration fees for Ice Golf will not be refunded due to weather conditions that create unsafe conditions for participants and sponsors. The event may be relocated should the lake be unsafe. Cancellation of the event due to weather or other hazards will be at the sole and absolute discretion of the Chamber President.

Equal Access Policy

The Chamber is committed to providing equal access to its events without regard to race, creed, color, sex, national origin or disability. The Chamber will make every attempt to provide reasonable accommodations.

Waiver

I wish to participate in the Prior Lake Chamber Ice Golf 2016 (the “*Activity*”), hosted by Water Street Restaurants Group, LLC doing business as Charlie’s on Prior, and its affiliates (collectively, the “*Activity Host*”). I state and affirm that:

1. My participation is voluntary. No one is forcing me to participate.
2. I understand and acknowledge the Activity I am about to voluntarily engage in is a sport, played with sporting equipment on ice, intended for adults, and thus, as a participant, I will be exposed to certain risks, including, but not limited to, sprains, strains, bruises, cuts, broken bones, and head injuries. I understand and appreciate that these risks, known or unknown, anticipated or unanticipated, may result in injury, death, illness, or disease to myself or other persons, and may result in damage, including complete destruction, to my property or the property of others. I further acknowledge and understand that I can avoid these risks by not participating in the Activity.
3. I understand and acknowledge that by participation in the Activity, I may be photographed or video recorded. I hereby grant the Chamber, Activity Host, as well as their successors, assigns, affiliates, and agents, the right to use such photographs or video recordings, regardless of their quality, for any purpose and in any manner, including, but not limited to, posting such photographs or video recordings to Facebook. I consent to the public association of my name with such photographs or video recordings.
4. In consideration of being allowed to participate in the Activity, I hereby personally assume all risks in connection with the Activity, and I hereby agree to hold the Chamber and the Activity Host, as well as their officials, employees, agents, members, and sponsors, harmless, and I waive any right to make claims or bring lawsuits against the Chamber, the Activity Host, their members, and anyone working on behalf of those parties for any injuries or damages arising from or relating to my participation in the Activity.
5. Notwithstanding the foregoing, this waiver does not apply to any injuries or damages that are the result of any willful, wanton, or intentional misconduct by the Chamber, the Activity Host, their members, or anyone acting on behalf of those parties.
6. I understand that entering into and signing this agreement affects my legal rights and results in my giving up or waiving certain legal rights and I accept this and sign this agreement of my own free will.
7. The terms of this agreement shall bind the members of my family, if I am alive, and my heirs, assigns and personal representatives if I am deceased.
8. My signature indicates I have read this entire document, understand it completely, acknowledge that it cannot be modified or changed in any way by oral representations, and agree to be bound by its terms.
